A Message from the North Georgia Community Foundation (NGCF) PRESIDENT & CEO AND BOARD CHAIR

We have always known that giving is a way of life in our North Georgia communities. This statement has never been more apparent than during the past year. 2020 marked NGCF's 35th year, and it quickly became a year of uncharted territory. However, even with the challenges and unknowns, NGCF still experienced inspiring moments and incredible milestones.

We started the year by introducing a robust **5-year Strategic Plan**. The NGCF staff and board worked diligently through remote meetings and socially distanced gatherings, to achieve the strategic plan's goals, and we never lost sight of the needs of our fundholders, nonprofits, and community.

In a quick response to the widespread pandemic, we established the NGCF COVID-19 Relief Fund. Through this Fund we were able to stand in the gap and help facilitate relief grants to nonprofits serving people in our community with critical needs. Over \$1 MILLION in COVID-19 relief grants were awarded in 2020, with the Fund positioned to continue more relief grants into 2021.

While facilitating relief grants, NGCF continued to work alongside fundholders and nonprofits. Through stewardship of these relationships and funds, NGCF surpassed a huge milestone of **\$100 MILLION in Charitable Assets** during 2020.


COVID-19 relief grants and **\$385,000 in student scholarships** were part of the **\$11.3 MILLION** total grants NGCF facilitated in 2020. With these grants, NGCF celebrated reaching **\$106 MILLION in charitable giving** since our inception in 1985.

NGCF was strong going into 2020. There is no doubt that by fighting the good fight together, we came out even stronger. We stood alongside our fundholders, nonprofits, and community through financial giving, a statement on racial justice, nonprofit educational programming, and other supportive and encouraging ways. We proudly saw our community come together more than ever before and proved that a **generous and giving spirit is very much alive in North Georgia**.
